

2012 Toledo Auto Show \$15,000 Towards the Car of Your Dreams Giveaway Official Rules No Purchase Necessary

1. All contestants must be 18 years of age, and must be a legal resident of the 50 United States or the District of Columbia.
2. Employees of the Toledo Automobile Dealers Association, its members, and their immediate families are not eligible to participate. Employees of the SeaGate Convention Centre and their immediate families are not eligible to participate.
3. No current member of a high school golf team, or current or former college or professional golfer is eligible to participate.
4. You may enter during the period beginning at 12:01a.m., December 28, 2011 and ending at 6:59:59 p.m., January 28th, 2012 by logging on to toledoautoshow.org and providing the requested information. Normal internet access and usage charges imposed by your on-line service will apply. Entries may also be submitted during show hours at the Toledo Auto Show between Thursday, January 26th, 2012 and Saturday, January 28th, 2012. All entries must be on official entry forms, no photocopies or hand-drawn entry forms will be accepted. Contestants may enter by completing entries on the contest computer database at the Toledo Auto Show located at the SeaGate Convention Centre. Limit one (1) entry per person/address per day either via the internet or in person. In event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed to be submitted by the person in whose name the web address is registered. For purposes of these official rules, all times are Eastern Standard Time and Sponsor's computer is the official time-keeping device for the Giveaway. "Day" shall mean each day during the entry period.
5. The sponsors are not responsible for lost entries, technical failures, or unauthorized human intervention. All entries submitted become the property of the Toledo Automobile Dealers Association and cannot be returned.
6. Incomplete entries or entries which the judges determine, at their discretion, to be incorrect, illegible, or not in accordance with these rules will be disqualified without notice to the contestant. 7. From the entries received, five finalists will be randomly drawn after show hours on Saturday, January 28th, 2012. A representative of the Toledo Automobile Dealers Association will notify all finalists.
8. In the order in which the finalists were drawn, each of the five (5) finalists will participate in an athletic event. Regulations describing the athletic event will be provided to each finalist on Sunday, January 29th, 2012 prior to commencement of the event. The first finalist to successfully accomplish the challenge will be the grand prize winner. In the event that no finalist successfully accomplishes the challenge, no Grand Prize will be awarded.
9. Finalists must be present to win. No representatives or agents may be substituted for the finalist.
10. While reasonable attempts to notify finalists will be made, it is the responsibility of the finalist to be available for notification. In the case where a finalist cannot be reached or is unable to be present on Sunday, January 29th, 2012, no replacement finalist will be chosen and the event will proceed with those finalists present. (Actual time of event to be determined.)
11. Odds of winning depend upon number of entries received.
12. Must be present to win.
13. A grand prize will be awarded to the first finalist, if any, who successfully accomplishes the event challenge. The grand prize is a voucher valued at \$15,000 to be used toward the purchase of one new vehicle from a member of the Toledo Automobile Dealers Association. The voucher must be redeemed by January 31, 2013
14. Upon the selection and purchase of a new motor vehicle, the Toledo Automobile Dealers Association shall remit to the dealer, on behalf of a winner, up to \$15,000 toward the purchase of the selected vehicle. The voucher may not be used toward the payment of tax, title, registration, or any other products or services. If the purchase price of the motor vehicle totals less than \$15,000, the winner will forfeit any remaining portion of the prize. If the purchase price of the motor vehicle is more than \$15,000, any additional amount needed to purchase the vehicle is the winner's sole responsibility. Any additional financing needed to purchase the vehicle(s) is the winner's sole responsibility and subject to the winner's credit approval.
15. All decisions of the contest judges are final.
16. In the event viruses, bugs, unauthorized human intervention, Acts of God, acts or regulations of any governmental authority, war, national emergency, accident, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism or other matters beyond the Sponsor's reasonable control, corrupt, prevent or impair the administration, security, fairness or proper play of the Giveaway, so that it cannot be conducted as originally planned, except where prohibited by law, Sponsor has the right, in its sole discretion, to modify the Rules or to cancel, modify, terminate or suspend the Giveaway; and in such event, to select a winner by such method as Sponsor in its sole discretion shall consider equitable;

By submitting an entry form, contestants agree to be bound by the rules of the Toledo Auto Show \$15,000 Giveaway, and agree that sponsors shall have the right, free of charge, to publish and/or broadcast by any means the name, city of residence, photographs, video, and statements of the winner and finalists.

The winner must present valid identification with his/her photograph, name and address, proof of social security number, and sign an affidavit of eligibility and release to take delivery of the prize.
